Replication data and informtion

The replication material for our article *Preferences or blocs? Voting in the United Nations Human Rights Council* is composed of three parts: 2 data files (R dump files) and an initialization file for our jags model (`hrirt1at.ini`), jags-code used to estimate our models, and R-code used to generate our graphs and tables contained in our paper.

Data

We make available two R-dump files used in our paper, one for the basic analysis (`hrirtnat.Rmp`), and a second one for our robustness checks (`hrirtnat.Smp`). They have the same structure

Figure 1: Geweke-plots: general parameters of hierarchical IRT model with proposers




Figure 2: Geweke-plots: general parameters of hierarchical IRT model with proposers




Figure 3: Geweke-plots: θ s 1-8 of hierarchical IRT model with proposers




Figure 4: Geweke-plots: θ s 9-16 of hierarchical IRT model with proposers




Figure 5: Geweke-plots: θ s 17-24 of hierarchical IRT model with proposers




Figure 6: Geweke-plots: θ_s 25-32 of hierarchical IRT model with proposers




Figure 7: Geweke-plots: θ s 33-40 of hierarchical IRT model with proposers




Figure 8: Geweke-plots: θ s 41-48 of hierarchical IRT model with proposers




Figure 9: Geweke-plots: θ_s 49-56 of hierarchical IRT model with proposers





Figure 10: Geweke-plots: θ s 57-64 of hierarchical IRT model with proposers
