





Agreement on the use of the Geneva Emotion Recognition Test (GERT and GERT-S)

Researchers administering the GERT or the GERT-S via the online service provided by the Swiss Center for Affective Sciences, Ghent University, and the European Consortium for Research on Emotional Competence Assessment (EURECA) (free of charge) agree to the following terms of use:

- 1) The GERT is used for research purposes only. Any commercial use is excluded.
- 2) The study involving the GERT must be run or supervised by a person with academic background. Every person running the GERT must sign this agreement. For undergraduate and graduate students using the GERT, additionally the signature of a supervisor is required.
- 3) No copies of the stimulus set will be made or distributed.
- 4) A short description of the project involving the GERT (1 page max.) must be submitted to the EURECA prior to the study.
- 6) The GERT must be cited in the following way in any publication using the collected data:
