# LL.M. IN CHINESE LAW

## Program Description

- With China's rapid economic growth and rising international prestige, Chinese law has become an essential source of knowledge as well as a valuable instrument for international students and legal professionals who have business, cultural, academic or political links with China. Renmin Law School created the LL.M. Program in Chinese Law to meet the needs of the international community, helping them to gain an inside view of Chinese law from a first-rate legal institution in China.



- The LL.M. in Chinese Law is a two-year English Graduate Program taught in English offered by Renmin University Law School. This Program provides an invaluable opportunity for a selected group of students and professionals with at least a bachelor's degree to broaden and deepen their knowledge and understanding of Chinese Law and Chinese legal practice. The program seeks to attract intellectually curious and thoughtful candidates from a variety of legal systems and backgrounds and with various career plans.

## Admission Procedure



### Step 1: Application

All application materials should be sent to the LL.M. office by mail. Please scan and email the application material files to [masterchinalaw@126.com](mailto:masterchinalaw@126.com) before you send the hard copies by post.

### Step 2: Interview

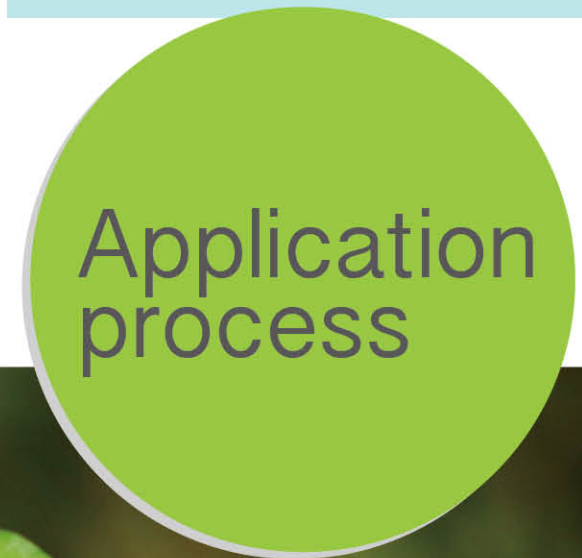
After receipt of application materials, all applicants should attend a specialized comprehensive interview in English organized by the law school. Please contact us for more information after submitting the application materials.

### Step 3: Admission

The Admission Committee of the Law School will make a decision of acceptance or rejection based on the applicant's performance and perceived cultivation potential. The Admission Committee of the University will approve the final admission decision. A pre-admission notice will be sent within two weeks after successful completion of the interview, and an official notice will be sent in late June.

**Eligibility:** Non-Chinese applicants who have obtained a bachelor degree or above. Preference is given to those with a degree relating to law.

**Deadline:** The application period opens each year on October, 10<sup>th</sup>, until June, 10<sup>th</sup> the following year. Applications for the Chinese Government Scholarship should be completed by April 10<sup>th</sup> during the application period.





## Application materials

- 1 One application form for LL.M. Program at RUC with signature;
- 2 One photocopy of passport, diploma and original academic transcripts;
- 3 Two recommendation letters by professors or associated professors;
- 4 A two-page Personal Statement indicating education and work experience, research interests, plans and personal development objectives after graduation;
- 5 Four physical copies of recent passport-sized photos;
- 6 Proof of language proficiency for non-native English speakers: IBT TOEFL score of 98 or above, TOEIC score of 900 or above, or IELTS 6.5 or above, or an equivalent score of any official English proficiency test or the certificate of graduating from a program taught in English

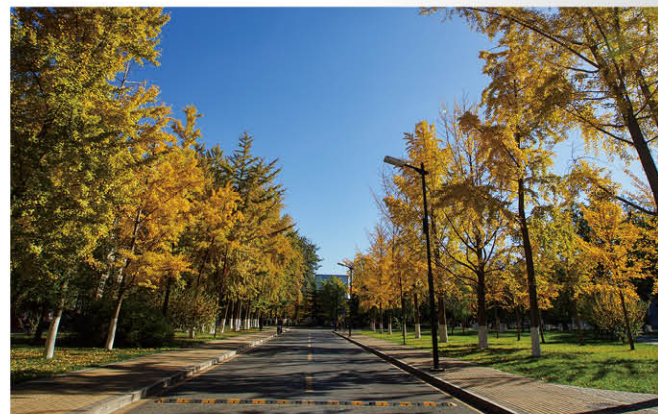
## Tuition

The LL.M. Program in Chinese Law is CNY 70,000 per academic year for the duration of the two-year English program.

## Scholarships

RUC Law School supports various scholarships to participants of the LL.M. in Chinese law. Scholarships include:

- (1) Chinese Government Scholarship (CGS): The Chinese Government Scholarship provides a full scholarship for international students covering tuition, accommodation, living allowance and medical insurance to study in China. The candidate from LL.M. Program may apply CGS from the following programs: Bilateral Program, EU Program, AUN Program, PIF Program, MOFCOM Program, Chinese University Program, etc. For more information, please visit: <http://www.campuschina.org/>
- (2) Beijing Government Scholarship (BGS): The Beijing Government Scholarship is established by Beijing Municipal Government to attract and support excellent foreign students to study in Beijing. The BGS New Student Scholarship and BGS Belt & Road Scholarship can be used to cover the full or partial tuition for LL.M. Program.
- (3) Renmin University Scholarship (RUS): Renmin University of China provides Belt & Road Scholarship and Forbidden City Scholarships for the candidates from Belt & Road countries to cover full or partial tuition, accommodation, living allowance and medical insurance to study in our LL.M. Program. RUC Law School also provides scholarships to cover the tuition fees fully or partially.
